KEY FUNCTION OF POSITION:

- Assist in timber harvest layout, permits, and notices of operation with regards to silviculture and stewardship principles.
- Maintain knowledge and understanding of local markets and mill utilization standards.
- Address land use issues and make agreements as needed.
- Acquire and maintain a drone pilot certification through the Federal Aviation Administration (FAA) in order to facilitate the use of drone technology.
- Maintain knowledge of current wildlife and environmental issues addressing any concerns that may arise.
- Maintain understanding of current industry standards; ensure full and appropriate compliance with federal and state forestry laws.
- Actively participate in the implementation and utilization of GIS.
- Actively participate in and implement CG safety training and policies.
- Support and participate fully in local SFI program.
- Ensure that environmental or financial risk management reporting is conducted in a timely and professional manner to your Area Manager and, if appropriate, local Safety Coordinator.
- Respond to internal and external information requests in conjunction with management and team members.

- Actively participate within the organization to ensure all timberland management investment services meet or exceed client commitments.
- Represent Campbell Global at all levels maintaining positive public relations.
- Other duties as assigned.
